I already said that If I misconstrued what you said, then I'm sorry about it. Glad you are able to send this lead sheet to you.

We never really got a chance to follow up on my conversation with you (which was maybe around February 21, 2019, because I had just landed in Europe when you called me and I still had jet lag) - regarding your decision to cancel us at Newport this year. I just wanted to restate that I understand your position, and I do not hold this personally against you or anyone at Newport. I've been around long enough to know the deal, I understand that you are in a tough position, and I understand this current energy that this #MeToo movement has produced. There is a lot of fear, there are many legitimate claims of abuse, harassment, etc., and there are a number of women who are using this moment to get revenge and pursue vendettas.

But this is not your concern, you have to deal with the business of running that festival, and believe me, I get it.

So I just wanted you to understand that I have zero vibe against you, you are one of the great musicians out here, and this does not change for me.

I'm dealing with this litigation, and it's a process that will play out over time. But I know that I am guilty of what Maria Grand has accused me of, and if I am allowed to show my evidence, this will be easily proven. But the court system takes time, and I'm not in control of how long this will take. But I will keep you informed.

In the week since you and I spoke on the phone, there has been a lot of conversation at CalArts about Steve's situation. We had an amazing forum on Monday with the "Women in Jazz" panel discussion, which was incredibly open, positive, and enlightening and I was really proud of everybody. We didn't get into the news reports about Steve during that forum, but focused on the daily human interactions at CalArts, in the jazz and creative music community, and generally in our culture.

However, there has been a steady stream of students wanting to talk to me individually about Steve, and people are very worried and concerned about it. None of them feel like we can include Steve on our visiting artist series this fall under the cloud that exists now. I've talked to the dean and sought his advice, and he also felt strongly that we should not go ahead with the December 3 workshop. In every case, I've presented some of what you told me and reminded them that there are two sides to this, but nobody is supportive of having Steve come to CalArts right now.

I'm grateful to you for our talk last Thursday, and am so sorry that you are caught in this mess. Steve has been one of my heroes and his music and teaching has influenced me and our students for many many years (as I know is true for you), and it is really upsetting, discouraging, and sad to think about all of this. I hope that there is some way to resolve it and move forward. The only good part is that our students' generation will hopefully learn how to avoid these problems in the future and include women musicians as equal partners and trusted and respected colleagues. It feels like that is happening at CalArts.

I probably should have called you to let you know, and I'm definitely up for another phone conversation if you'd like to talk more about it. But I wanted to confirm that we won't be doing the Mon Dec 3 workshop so there was no confusion.



This is very sad - and is yet another cancellation, among many, caused solely by Maria Grand's malicious and false accusations against me. The damage is piling up, and has been going on

This lawsuit is my lawsuit that I am bringing against Maria Grand, stating that she is not telling the truth in her accusations against me. It is not a lawsuit that she is bring against me! But even the fact that I am proactively defending myself against Maria's defamatory statements seems to make no difference to anyone. Just the appearance of a young woman accusing an older man is enough - I'm guilty until proven innocent.

Unfortunately, I cannot say that I didn't expect this. Personally, I don't even want to come back to your school, or Cal Arts, even after it is proven that Maria is lying, if your principle and the Cal Arts people are going to be this close minded. And you can pass this email on to them, although I'm sure it will make no difference. Even if there were some concern, there is nothing that could possibly happen during our

And in all of these situations, no one even bothers to come to me to ask me my perspective. Everyone is so petrified of this #MeToo movement, and of giving the appearance of gender equality, that they are cannot even function with any sense of fairness. I just wanted to let you know that I spoke to Hollis and she (I thought I was dealing with the man this whole time) said that she is going to get a few security guards to be at the concert in case there is any disruption during your concert, in light of The Morning Call article that came out over the weekend. She said that she was pissed that they ran the article before the concert. She also said that she realizes that because you are the one suing, that a person's attorneys would not advise their client to proceed with a suit if there wasn't substantial evidence to prove the accuser wrong.
