Hey Steve,

Thanks.

I only entered (and even had the thought of entering) a relationship with Steve Coleman because he was so insistent. It was not my idea. I didn't go into lessons with him thinking he was attractive. I went into lessons with him thinking he was great and being drawn to his knowledge and musicianship - not trying to have a relationship with him.

I never propositioned him nor would have wanted to. He's the one who insisted. He insisted for two years before I said yes to anything. It was not a decision I made out of happiness, it was a decision I made because I felt I had no choice. My resistance was broken down little by little. He held knowledge as a dangling carrot in front of me and made me feel that I had no choice but sleep with him in order to become a good musician.

I hope my letter makes that clear... I never *wanted* to be in a relationship with someone that much older than me. It wasn't something I was craving. But once I became intimate with him all the lines blurred and I felt that I needed him, and I fell for him. I wish I hadn't; I wish I had more courage, more support, more options, and didn't go through that. Anyways, after I started resisting his advances, it was only harassment and coercion. I want to stress that again. After September 2013, all I was is harassed. It's a long time to be harassed. I made it clear many times that I wanted him to stop propositioning me, and he didn't care. I'm highly annoyed that this was not more clear in my letter and that you felt the need to stress that relationships should be kept out of work. This isn't about relationships. It's about abuse and harassment.

My phone isn't blowing up. Most people don't really want to talk about this. They'd rather turn a blind eye, even when presented with the evidence. It might be more comfortable for them to do so. I don't know. I think a lot of people don't have any kind of courage, unfortunately. Any kind of change frightens them. And this is me being nice, I'd rather not say exactly what I think in an email.

I really strived to make this letter as impartial as I could but now I kind of regret that. I think it might have put too much responsibility on myself. I was really young and clueless and easy to manipulate. This isn't my fault nor my doing - and I'm not saying that's what you're saying but I want to stress that. I was manipulated, abused, and harassed. That's just the truth, ugly but real.

People in the music world are going to do whatever they're going to do... To be honest I'm tired of this scene anyways. I see through people's hypocrisy. I'd rather do my own thing and play music that's more meaningful to me anyways. After all, I'm not so interested in being a part of the boys' club. I've seen it from the inside and it's not that deep.

Thank you for being an example of something different, for being a good family man, for being a good person. We need more people like you.

Hi Maria,

I just read the letter in detail.

It is stunning.

It contains so much honesty - and so much pain.

Maria - you are so amazing and so wonderful. This is all so brave.

I don't think you should be worried about repercussions. I think you will have two camps of people — those who honor you, 'see' you and admire you.

And those who think you opened a door you shouldn't have and 'bit the hand that fed you'. They can drop dead.

You have just carved out a clear path for yourself. Stay in the light!!!! Stay with those people who adore you for YOU - your brains, your talent, your spirit -

not your body - You will actually have it easier now because you should be able to see who sees your true self and your true spirit. Insist that people deal with you holistically and professionally.

I think the short answer is that people need to separate personal from professional arenas.

I learned a lot about this from watching my father. My father - who just died in March at age 91 - was a remarkable man.

A brilliant neuro-scientist — chairman of the Neurology Dept at Columbia for many years -and an educator, author, editor, scientist and more.

He was also stunningly handsome - like Gregory Peck, and a socialist type who spent his whole life trying to make the world better —and opening up

the world of medicine to women and minorities for decades - even down to changing the language doctors use to describe patients of different backgrounds.

Why do I bring him up? Because he had very strict moral codes - and as a teacher, he would never cross the line and enter into relationships with his students.

They were young women who admired him, looked up to him just like you did with Steve — and also thought they might get ahead in their careers if they were intimate with him. And he was a guy - he noticed every cute and brilliant woman who became his student - I just know he did.

So he had strict boundaries - no hanky-panky. Period. End of story.

"This is a professional arena - and it will stay professional." if not - get out. Each person is to be judged on their merit, what they know.

Always professional.

And in a medical school, hospital setting it is much easier to monitor all of this - than in a small jazz ensemble on the road.

I totally understand why you fell in love with Steve - he is a remarkable person and had so much to teach you. And, as you write, you were totally flattered that he would pay attention to you.

but wouldn't it have all been easier -for both of you - if he had drawn strict boundaries and told you to get a boyfriend your own age - and read books with him, lie in bed holding each other and listening to Coltrane and Cecil Taylor and Sly and the Family Stone—reading Joyce, and Shakespeare and Neruda? That is what brilliant 17 year old girls should be doing.

I taught at a college last year near Seattle and I had classrooms with 55 students. And a lot of very smart and very attractive young women. I made it very clear to each of them that I was off limits in any romantic way - and that I am happy with my woman - and that they were safe coming and talking to me about their lives. I saw one after another who had been victims of sexual abuse and confusion - crappy relationships - some were veterans who had suffered rape in the military - some were just beautiful young women who had chosen awful guys. I'm not sure why so many women are drawn to men who are mean and totally self centered.

This is why it is so important to have a clear definition of professional vs personal spheres. If Steve wants to be sleeping with young women, they should not be women he is teaching or in his band. It can only lead to drama and pain. I can certainly see the attraction - the intimacy, the knowledge -even just the traveling and exhaustion.

I also teach in prisons. And before we are allowed to enter the prison we have to take classes in sexual harassment. It is made clear that prisoners can NEVER enter into consenting relationships because they are desperately needy - for attention, or drugs, or communication, or whatever. and it is made clear that any teacher - man or woman - who enters into a physical relationship with a prisoner is committing a FELONY. Period. And this keeps everything running smoothly and keeps people safe from abuse and harm.

Adult men should be adults - and have adult relationships. Adult men should not be sleeping with students, with people underage, and taking advantage of women who feel that they need this man. Adult men should have healthy relationships in their personal lives. They can be monogamous or polyamorous - who cares? That is up to them. But not with students, not with people too young, not with people desperate for attention. If Steve doesn't want to get married and have a real long term love relationship that grows over time, that is his business - but it is too 'convenient' to take advantage of young women who admire him and want to learn from him.

I learned from a good man. A great man.

I drew those strict boundaries with my students -and it was good for them -and good for me.

The scariest part of your letter is that you became suicidal. This is really important to be open about and get out of the shadows.

You entered a kind of dark place - and there were demons lurking - telling you not to be square -and to satisfy them - this is an old trick -

Even Shakespeare wrote about it (we have to talk about Measure for Measure sometime)

It is not your fault - your talent got ahead of your youth and you were not in a protected setting like a college or a medical school.

You didn't have the men looking out for you that you deserved.

One of Steve's problems is that he doesn't have children. Men who have daughters are much wiser! I am lucky to have a wonderful daughter.

But some men, too many, are just totally fucked up and won't change. We all have to be wary of them - they fuck up the world.

Your phone and email must be blowing up.

I'm here if you want to talk — sooner or later - it doesn't matter.

Thanks. Yes you can share it with Sumi. She's great. I met her this summer in Philly, we were both teaching at the Kimmel Center.

Can you please share this version of the letter? It's slightly amended. Someone told me that when they told me to "take one for the team" it was a miscommunication so I removed that from the letter (although the general lack of support is still unchanged).

May I share your letter with my good friend, the pianist Sumi Tonooka? You should meet her sometime.

I am so impressed with you. I'm sorry to hear it all. It is a terrible story.

After spending a year teaching college students last year, I think it is really important for men in positions of power (at any level) respect themselves enough (as well as their mothers, daughters and all women) to draw the line --and take those positions responsibly. Young women have so much to go through. Men have to learn to think from places other than their lizard brains. We have higher consciousness for a reason!

This behavior is unconscionable.

I'll read your letter again - and write to you in a little more depth soon.

Hey,

There's been lots of talks about sexism in the music industry. I wrote a long letter about my experience with it. It's attached to this email.

If you have time please read it. It's not public at the moment because it's legally dangerous for me to publish this (even though I've removed any mention of names), but I need people to know what's up. The content of it is definitely triggering so please don't read it if you are not in an emotionally stable place.

Feel free to do whatever you want with the information that's in this letter. It's not a secret. But please don't forward the actual letter to anyone. If you think I should send this to someone, email me and I'll do it.

I'm sending you this so it can be the start of a larger conversation about what's acceptable and what's not. Personally I'm doing okay and I don't really need moral support and although I'll happily welcome it if that's what you feel, I'm definitely not looking for pity. What I do need is for awareness to be raised on this huge problem. This isn't just something that happened to me. You can bet something similar, although hopefully not as bad, has happened to almost every woman musician you know.

I really think the whole music community can do better and I'm sending it to you because it's important personally for me that you read this and also because your voice counts and what you think matters.

This might end up being public at some point, but I have to make sure it's done in an effective way and that I protect myself too. So for now, I'm only sharing it with people privately.

Dear All.

I really appreciate your responses and have been sitting with all this a lot since receiving the letter.

Regardless of our various opinions about x and whether or not he should be "punished" (even if that were our purview, who among us is in such a position of power?), to me, right now, it seems to boil down to two imperatives, both of which I believe should be considered and acted on regardless of who x is.

- 1. protecting and supporting María as we can
- 2. making sure further predation from x does not occur

The first seems obvious and simple for the time-being but will certainly grow more complicated as this comes out...and I believe it should and will, although I of course support allowing María to take the lead on that.

Regarding the second, we cannot unknow this story, and who among us doubts any of it? That creates a moral obligation that doesn't seem vague to me.

Especially to you guys in the room, who hasn't been privy to stories about x which make allusion to perhaps decades of related behavior? That just happened at Banff last summer, as a longtime collaborator of x, upon hearing of María's emotional troubles and how they might relate to her experiences with him, gave a saddened, knowing head shake and made clear that he'd seen this many times before

This letter gives painful detail to some of the specific ways such rumors can play out in reality. Too often, stories of such predation are accepted as part of the package deal with high-acheiving super-alpha male artists. Once we are confronted, though, with detail regarding the kind of emotional, physical, spiritual, professional, and creative damage this can leave with its victims, how can we continue to just shake our heads? That feels like complicity to me.

There are many illuminating articles going around, but this recent op-ed by comic Laurie Kilmartin speaks of numerous professional ramifications of this for women https://www.nytimes.com/2017/11/10/opinion/sunday/louis-ck-harassment.html.

And when we consider the professional barriers and difficulties this behavior can create for our sisters, and if we pretend to care about our art and all it might offer, how can we be ok with their voices being shut out? It's our loss, too...everyone's.

I'm open to hearing more detail on how we can protect the daughters of his current collaborators or any young women in the future without naming names. But for now, I remain skeptical.

Knowing what we know, I do feel we have a moral obligation to name names in this case, and it's just about how to manage that in a way that causes the least longterm damage to María and her prospects for a healthy career and relationship to music.





To: We Have Voice,

As most, if not all, of you know, I have been publicly accused of sexual harassment by Maria Grand, a founding member of your *We Have Voice*organization. I am writing this letter to categorically denounce this accusation as false, and to appeal to you to hear both sides of the story before reflexively rushing to judgment.

Please refer the enclosed PDF for a detailed account of this false accusation, offering evidence to the contrary, and a request for some kind of mediated resolution. All of my prior attempts at mediation over the last 4 months have been rejected. Hopefully, after reading my letter, we can all agree that the best way forward for the health of our community is resolution.

I would like to state that do not consider myself in a fight with the members of the *We Have Voice* organization, nor am I in opposition with most of your stated goals. However, while I applaud the work that your organization is undertaking, I am asking that you work with me and others to resolve these underlying contradictions. Accusations that have not been properly vetted, and which turn out to be false, harm the person accused (perhaps irreparably slandering their name), harm our entire music community, and cause unnecessary divisions in an already small and marginalized creative music scene. I do not undertake this lightly, I am saddened by recent events, and I wish harm to no one in our creative music scene. However I have been unnecessarily publicly attacked several times, and after trying many times to resolve this privately (and at great expense), it has taken a lot of negative energy to push me to this point of defending myself.

Please refer to the attached PDF for details.

In full disclosure, and to avoid further clandestine mailings, the following community members have been copied. Many were secretly sent Maria's original accusation letter sometime around November 2017. Others have since been forwarded Maria's original letter, or found out about it via another method. I did not find out about these mailings until January 2018, and by then a lot of damage had already been done to my name. This was done on purpose, to unfairly deny me an opportunity to respond in my own defense.

I am sending out this letter using the same method that I believe Maria Grand used when she sent her original accusations, however instead of doing it secretly, I am choosing to be transparent regarding who is copied. I am not attacking anyone, I am only interested in defending myself against ongoing attacks, bullying and past, current and future false accusations slandering my name.

I look forward to your response, and to beginning dialogue to find solutions to move us forward.

To: We Have Voice.

As most, if not all, of you know, Maria Grand, a founding member of your *We Have Voice* organization, has publicly accused me of sexual harassment. I am writing this letter to categorically denounce this accusation as false, and to appeal to you to hear both sides of the story before reflexively rushing to judgment. Your organization has put forward both an open letter and a code of conduct, which I support. However, if one of your founding members is allowed to make false accusations, and these assertions are taken as fact without any attempt at getting to the underlying truth, then the credibility of the organization and its entire premise should be called into question.

It is always easier to tear down the reputation of others than it is to investigate the truth. I would hope that we use this opportunity as a learning moment for future possible conflicts within our community, as this is not a hypothetical event, but rather ongoing misrepresentation and slandering of my reputation. I would hope that We Have Voice has an emphasis on the "We" and seek to improve the environment for all people.

I am finally emboldened to write this now because of an incident that happened at Maria's concert at Roulette on Tuesday, which I attended. I went because I, perhap sfoolishly, thought that maybe our issues were behind us and that this was my extension of an olive branch. As you might know, I was asked to leave the premises by Maria (Imani Uzuri told me that Maria wanted me to leave), and it was clear that all who tried to remove me believed that I had indeed sexually harassed Maria. At least three men jumped into my face as if they wanted to fight me. This was the last straw for me to try to handle this quietly. Until now, I have hesitated in publicly telling my side of the story. But now that I see the extent of the damage she is causing to my reputation, I must s peak up now or forever allow hers to be the only on-the-record narrative.

I want to state this simply: I was involved in a six-year on-off relationship with Maria, from 2011 through 2016. Our relationship was unusual, intense, argumentative, and passionate, but it was also completely consensual and should have been private. Sometimes I pursued Maria but *often* she pursued me. No one was forced to do anything. I never threatened to fire Maria from work if she did not have sex with me. The relationship did not end well, as many do. Unfortunately, this should be our private business, not the business of our entire musical community.

"Sexual Harassment" is about "unwanted" sexual advances and attention. The person who is claiming to be the victim of sexual harassment cannot at the same time be aggressively pursuing the person that she is accusing of harassment. I have spent months going back through past email and text exchanges and they document the complex nature of our relationship. They also show, again and again, that the pursuit went both ways, which thoroughly refutes Maria's accusations of sexual harassment. I have collected these exchanges in a master document, completely unexpurgated, and not cherry-picked only to prove my point, something that Maria did in the letter she sent out to the public. In order to defend myse f, I am willing to share this with any interested parties, despite the embarrassment, because being falsely accused of sexual harassment is even worse.

I am aware that there are people who will not believe my denials of sexual harassment. And Maria will present her own documentation to support her narrative (as she should).

However I have all of the same or similar documentation, so I can counter any evidence that is cherry picked and taken out of context. I welcome the fair vetting of both of our stories. The bottom line is this, in all of Maria's narrative, she has never once mentioned or shown that there was sexual aggression on her part, in all of the years that she is claiming harassment. Had she mentioned this, no one would have believed her accusations, and Maria knows this, so she deliberately left this out. *There is no hint of Maria's sexual aggression in her accusation letter*. This is disingenuous and misleading at the least, and demonstrates that Maria was consciously trying to manipulate emotions of sympath yfrom the recipients of her letter.

I've already tried to get several individuals in our community to mediate this issue, but these eff orts were rejected. I then sent a formal invitation to Maria requesting professional mediation, which I would have thought that Maria would eagerly participate in, given she is telling everyone that she is convinced of the veracity of her accusations. Maria received my letter and has ignored it. I continue to welcome the opportunity to do this in any forum , including with members of We Have Voice, in order to help get to the objective truth. I am aware that We Have Voice is not a policing organization, but through your Open Letter, Code of Conduct and various interviews, you urge *all of us* to be vigilant in ferreting out bullying of any member of our musical community, regardless of sex, age and position.

I applaud your eff orts in requesting that the music community hold itself and others responsible for reporting and stopping abuse, harassment and bullying. But there is no mention in your code of conduct of the rights of individuals being accused. No mention of properly vetting accusations, hopefully before they become public, but if not afterwards. If the energy can be generated to support an accuser (i.e., repost their statements, praise their bravery, etc.) then we should also be willing to approach those accused and vet and repost their statements. This is only fair. No individual's narratives should be believed without looking at the other side and at least asking for the different narrative. If you advise people to freely call out people who are accused of being sexual abusers/harassers, but stay silent for those who are falsely accused, aren't you just creating another problem that will ultimately delegitimize your work?

The blowback from Maria sending her letter to fellow musicians, concert promoters, journalists, professors, public sts, etc., has definitely affected my everyday existence. Negative vibes have increasingly been directed my way from some members of our music community. Therefore, this current email is also going out to all of the people that I know Maria sent her email to, and to others that I know received forwarded copies of Maria's email. Surely my email will also spread beyond the original recipients. I am also aware that some of you are close friends of Maria's and will stand by her at all costs. I cannot control what each of you will think about this, I only am concerned with getting out the truth, and to stop the bullying, intimidation, black-balling and lying from continuing.

Please respond to me at your earliest convenience. I am always open to dialogue on this particular issue, as well a sa llof your la rær concerns. I will also attend your opening meeting on May 7th, 2018, as this meeting is about *promoting the code and fostering further conversations*.

Addendum 1: explanation of evidence of communications between Maria and myself Anyone who does not need to see my evidence in the addendum can stop reading now.

As I am unfortunately well aware that no one will believe a person in my position proclaiming innocence, I will let you see for yourself from Maria and my own words, starting with the *September 2013* time period that Maria claims I began sexually harassing her. According to your own definition on your website, sexual harassment is first of all "any unwelcome behavior of a sexual kind". A person cannot be inviting sexual behavior, and still claim sexual harassment during the same time period. There were times when Maria rejected my sexual advances, and there were times when I rejected the sexual advances of Maria, as in any ongoing on-off relationship. I have evidence for all of this as well. But as you can see, Maria's sexual aggression continued throughout all of the years that she claimed that I was the sole sexual aggressor. It is not my desire to attack Maria personally, but I see no other way to prove my claims. As I was told at Roulette, "no one believes you, everyone believes that you are a sexual harasser."

I really cringe having to do this, as it is indeed embarrassing to both of us. However I did not choose to make this a public fight. And as the false accusations have still continued - with very negative results, I agonized over this, and sought out a lot of advice. But at this point, I don't know what else I can do but defend myself, since the bullying and accusations are ongoing.

I will add that there has not been one case in the entire group of #metoo accusations that is even remotely like this situation between Maria and I. Not one of those #metoo cases involved an ongoing long term (6-year) intimate relationship. There is a reason for this, and this alone should give any fair-thinking person pause as to the veracity of Maria's allegations. But some have chosen to ignore this, so I must give examples of Maria's sexual aggression. And Maria's more recent claims of sexual intimidation are even more ridiculous.

If not for Maria's decision to disseminate these accusations of sexual harassment accusations against me to the public, in a clandestine manner in November 2017, none of this would be happening. I derive no joy out of doing this, as people will be hurt, including myself. But I am still being accused, bullied and vilified, so I must set the record straight.

It is my hope that some of the experienced creators in our music community can find a way to resolve and mediate this issue, and the riff that has formed between some of us can be at least partially healed (many people have taken different sides, people have left ensembles, stopped talking to each other, etc.). We are all here to create, not tear down.
